**VOLUNTARY ANNOUNCEMENT
INCREASE IN SHAREHOLDING
BY SUBSTANTIAL SHAREHOLDER**

This is a voluntary announcement made by Qianhai Health Holdings Limited (the “**Company**”) to inform its shareholders and potential investors in relation to the increase in shareholding by a substantial shareholder, Super Generation Group Limited (“**Super Generation**”), a company wholly owned by Mr. George Lu. Mr. George Lu is also the chairman and an executive director of the Company.

The Company was informed that Super Generation acquired 11,020,000 shares of the Company (the “**Shares**”) of HK\$0.004 each at HK\$0.088 each on 11 July 2017 (the “**Acquisition**”)

Immediately prior to the Acquisition, Super Generation was interested in 7,832,000,000 Shares, representing approximately 46.06% of the total issued share capital of the Company as at the date of this announcement. Immediately after the Acquisition, Super Generation was interested in 7,843,020,000 Shares, representing approximately 46.12% of the total issued share capital of the Company as at the date of this announcement.
